REPORTS

Schools: Ronan stated that under new Superintendent & admin staff off to good
start. Fanning reported that a prelim budget expected 11/1.

Symmes: Foskett said ARB still negotiating w/ neighbors. Knows of no
roadblocks.

Fields: Olson reported that user groups are working toward a warrant article that
would require a user fee adequate to offset most of the \$40k turf management contract.
This group to look for ways to make full use of the artificial turf at AHS, to save the
grass fields.

Budget & Revenue Task Force: Tosti reviewed tonight's 6:00 mtg.

The Manager updated & explained the 5 yr plan. Jones to circulate by
email. Superintendent will support. Discussion of what FinCom can do to hold
to this plan. Deyst suggested that some groups will want relief. Tosti
recommended letter from BOS to Minuteman. Fey thought Park Ave Fire Station
might cost more than budgeted. Foskett warned against micromanagement.
Simmons to find status of fire station project.

Superintendent reported on seminar on better way to approach health
insurance collective bargaining. Before bargaining starts, have a fact finding
study w/ all stakeholders represented to reach understanding of options.
