VISITORS: TAC Chair Ed Starr, CRB Member Joe Rosselli

MINUTES of 2/11 approved as amended. Unanimous.

ART 62 TAC APPROPRIATION: Starr reviewed the appropriation history of his committee stating that as of Jan TAC had \$15,938 in unspent funds. TAC uses its appropriations to conduct traffic-related studies and to provide seed money for traffic related improvements in town. He mentioned thermoplastic street crossing marking. He requested that the committee be allowed to carry over funds for 3 years.

VOTED to authorize rollover of TAC funds to FY09 not to exceed \$15,000 with the exact amount to be provided later by the TAC Chair. Unanimous.

ART 41 EXTEND VETERAN BENEFITS: Rosselli requested reconsideration of the FinCom's vote of no action taken on 2/4. He stated that John Maher would accept "widow" in place of "estate" for the recipient of this benefit to a disabled town employee who was also a qualified military veteran. Under questioning, Rosselli agreed that the recent legislation, which extended this benefit (formerly received only by regular retirees) to disabled retirees, explicitly banned deceased employees from receiving the benefit. He was unable to explain why this provision was in the legislation nor why he considers it unfair. Rosselli also stated that the entire CRB supported the warrant article. He suggested that the town had a patriotic duty to support the warrant article. If the legislature were to amend the law as Rosselli requests, at least 16 widows would benefit at a cost to the retirement plan of \$131k. After considerable discussion, the FinCom declined to reconsider its previous vote.

BUD 2 BoS: GenGov SubCom (DuBois), using a handout, reviewed both the election budget and the administrative budget. Many questions concerned the growth of election costs and the growth in the office staff. The % increase over FY08 will exceed 2.7%. A reduction in the Comptroller's budget may bring the total increase for the appointing authority into line.

VOTED \$398,558 Unanimous.

BUD 10 LEGAL: GenGov SubCom (Howard), using a handout, explained the changes in this department associated with the retirement of John Maher.

VOTED \$460,048. Unanimous.

BUD 17 STREETLIGHTS: PubWks SubCom(Olsen) recommended the budget as revised by the Manager.

VOTED \$418,893. Unanimous.

BUD 21 LIBRARIES: LibHumSer SubCom(Franclemont) recommended the budget as revised by the Manager.

VOTED \$1,898,988 Unanimous.

BUD 25 RESERVE FUND: Tosti recommended the budget as printed, \$450,000 a 12.5% increase over FY08. He stated this was part of a plan to increase the fund to 1% of the budget. Foskett moved to increase this to \$500,000. Members discussed the pressure on

department budgets as they have been squeezed by health insurance inflation. Of particular concern is overtime, retirement deferred compensation, schools and ice & snow. Carman to request the list of uncompensated absences from the Comptroller. The motion to appropriate \$500,000 failed 6-9 because of concern with defending such a large increase and the message it might send to department heads.

VOTED \$450,000. Unanimous.
